# DRESS CODE

# CLOCKING PROCEDURE



- All students are required to clock with fingerprints to earn CLOCK HOURS
- Student may be dismissed from school if found clock in/out for other students
- What if you forget to clock in/clock out?
  - > The student may loss all clock hours for the day

# STUDENT CONDUCT & DESIRE CHARACTERISTICS

# STUDENT CONDUCT/ DESIRE CHARACTERISTICS

1. Students are expected to follow the Dress Code Policy
2. At the discretion of the school administration/Director, a student may be dismissed from school if found:
  - a. Intoxicated or drugged state of behavior,
  - b. Possession of drugs or alcohol on school premises
  - c. Possession of weapons on school premises
  - d. Behavior creating a safety hazard to other persons at school
  - e. Disobedient or disrespectful behavior towards other students, an administrator, or faculty members, or any other stated or determined infractions of conduct
  - f. Stealing tools, products, and personal belongings of others

3. Clock in and out for other students
4. Profane language and dissension that cause conflict and might lead to violence.
5. Unauthorized entry into the administration/Director Offices where confidential information is kept
6. Students are required to be courteous and professional to staff, fellow students, instructors, and clients
7. Beverages and food are not allowed in the training areas
8. Students must pick up and clean up after themselves
9. Students should be considerate of others and the facility
10. Students must make personal calls outside the classroom and classroom hours. In the case of emergency or employment-related calls, students must get permission from the instructor



# KIT POLICY

# KIT/ SUPPLIES POLICY

- Students will be given a one-time provided student kit that is appropriate for their course, if applicable.
  - Each student is required to look over the item before signing and be responsible for their own kit.
  - Student kit is one-time provided; upon final use or loss of all “Single or limited use” supplies or tools, it is the responsibility of the students to replace such items.
- Students are expected to purchase additional supplies excluded from the standard kit to complete the course successfully.

# CREDIT HOURS REQUIREMENT

Each student MUST first complete Freshman hours of training which consists theory and training on mannequins to be eligible to work on patrons.

# SATISFACTORY ACADEMIC PROGRESS (SAP)

- Students will be judged as making Satisfactory Academic Progress (SAP) by maintaining a cumulative grade point average (GPA) of 75 % or above at the midpoint of the program, and the accumulative attendance rate of 75% or higher.
- To avoid academic warning and/or probation, students must maintain a minimum GPA of 75% or a C and a cumulative attendance of 75% or higher. Students maintaining less than a 75% GPA and /or a cumulative attendance rate below 75% shall be counseled by their instructor, which will be noted on their progress report.

# LEAVE OF ABSENCE (LOA)

- **Each LOA will be taken for a minimum of 7 calendar days. LOA's will be granted based on medical necessity/major illness or a death in the immediate family.**
- **Leave of Absence requests may not exceed a total of 180 days in any twelve months. Upon the student's return, the student will resume the same payment period and coursework. The contract end date will be revised upon return from the LOA to extend the ending date by the applicable number of days.**
- Students must request a Leave of Absence in advance, in writing, stating the reason for the leave, including all required documentation (doctor's note with dates or funeral announcement) for approval by the appropriate school staff.

# DISCIPLINARY ISSUES & PROBATION

# FOR FAILURE TO MAINTAIN SAP

- Students who meet the minimum requirements of cumulative grade point average (GPA) of 75% or higher and the accumulative attendance rate of 75% or higher are considered to be making SAP until the next scheduled evaluation point.
- To avoid academic warning and/or probation, students must maintain a minimum GPA of 75% or a C or higher and a cumulative attendance of 75% or higher.
- Students maintaining less than a 75% GPA and /or a cumulative attendance rate below 75% shall receive a warning then be placed on probation after a positive appeal result.

# FOR NON ATTENDANCE

Any student who is a “no call/no show” violates the attendance policy. All unexcused absences of 14 days or more will result in the cancellation of your contract. Penalties for other unexcused absences and allow students tardiness include the following, with repeated violations addressed with increasing severity.

1. Verbal warning
2. Written warning
3. Corrective action plan with the school director
4. Three days suspension
5. Termination

# FOR VIOLATION OF THE SCHOOL'S CODE OF CONDUCT

Any student who violates the school's Student Code of Conduct may be subjected to the following actions, depending upon the violation, the severity, and other pertinent factors.

1. Verbal warning
2. Removal from class
3. Required corrective action contract, planned and approved by the school director
4. Written warning
5. Three days suspension
6. Termination
